- 1. Known issue with sorting lists alphabetically
 - a. Found on bug 1632430 : https://bugs.launchpad.net/evergreen/+bug/1632430
- 2. Reminder: do not add 092 for a local call number.
 - a. 092 is for a local call number, and local information does not belong on the bib record
 - b. 082 is the place for a Dewey number if not already recorded
- 3. When to Import New Records
 - a. Always double check the catalog
 - b. Discussed search settings and how to make best use of the Z39.50 page
 - c. Reviewed merging guidelines on the website
- 4. Discussed new Best Practices manual
 - a. This is available on the Missouri Evergreen website: <u>http://moevergreenlibraries.org/wp-content/uploads/2021/07/Best-Practices-for-Cataloging.pdf</u>
- 5. Discussed pre-cataloged items
 - a. Pre-cataloged items exist on the record with TCN -1
 - b. Easiest to identify to locate with barcode number after check-in
